Fitness, Health & Wellness

Strides for Justice 2017 was the 10th anniversary of our 5K run and 1-mile walk, supporting Prairie State Legal Services and wellness in the legal community.

This year's event raised a record contribution to Prairie State of over \$5,000, possibly approaching \$6,000 (depending on final figures). We almost matched last year's record of 195 participants (ending up with 191), and the sponsorships, particularly among law firms, were up considerably.

Thanks to excellent work by the race committee, and the usual great weather, the race/walk on Grandview Drive came off almost flawlessly, with a lot of compliments from the runners and walkers afterwards. Local running star Guillermo Rolon won the race for the fourth year in a row with a time of 16:53; Logan Block (6th) and Mitch Gilfillan (16th) were the top attorneys. Sarah Herbert was the top female, in 23rd place overall.

Hasselberg, Grebe, Snodgrass, Urban & Wentworth won the Debbie Ryva Memorial Trophy for fastest law firm, for the second year in a row. Jennifer Wolfe, Denise Conklin, and President Michele Miller were among age-group award winners for their fast times on the women's side. Ron Hanna, Kevin Miller, and Mark Wertz won awards on the men's side along with Mitch and Logan. Several children of attorneys won awards as well.
