

### **LAP Board President Announced**

PCBA member **Tim Bertschy** [second from left in photo], the managing partner of Heyl Royster, began his term as President of the Illinois Lawyers' Assistance Program's Board of Directors on November 15. "Tim's dedication to the Illinois Legal Community is extraordinary. LAP as it is today would not exist without his advocacy. He was one of the original architects of the funding that LAP receives from the Illinois Supreme Court. We're excited to have Tim as the President of the LAP Board of Directors to continue promoting wellness for the Illinois Legal Community," said Robin Belleau, LAP Executive Director.

"The practice of law can be extremely stressful," Bertschy said. "We know that anxiety, depression and substance abuse are especially



prevalent in the legal profession. During my term as LAP president, I will first focus on spreading the word that LAP is here to help lawyers, judges, and law students around the state, and I will make a special effort to reach downstate lawyers now that we have a Bloomington location. Second, I would like to use my position as a pulpit to encourage people to take that first step, which is to overcome the stigma of seeking treatment."
